

# Terms and Conditions Business Orientation Days 2022

## 1. General

### 1.1. Changes in the program are reserved

The Business Orientation Days 2022 always retains the right to make changes to the program. The Business Orientation Days 2022 will do everything within her power to ensure the offered activities will continue. If unexpected changes do occur, the Business Orientation Days 2022 cannot be held responsible. The committee will inform the student as soon as possible.

### 1.2. Deadlines for registration

Registration for activities with CV selection is possible until Tuesday the 20<sup>th</sup> of September 23:59. Registration for activities without CV selection is possible until Monday the 26<sup>th</sup> of September 23:59. ## 2. The event

### 2.1. Activities Business Orientation Days 2022

During the Business Orientation Days 2022, the following activities will be offered:

- Presentations;
- Masterclasses;
- Workshops (with CV selection);
- Individual meetings (with CV selection);
- Company lunches (with CV selection);
- Company dinners (with CV selection);

Although the multiple activities are planned to take place at a fixed period of time, it is possible that an activity may take longer. The Business Orientation Days committee 2022 tries to prevent this as much as possible, but cannot be held responsible in case this occurs. If it does occur that you risk missing a next activity due to a possible extension of the previous one, you are allowed to leave the activity you are attending before it has been finished.

### 2.2. CV selection

As mentioned before, some activities contain CV selection. With CV selection, the company can select students who best suit its preferred job profile and wishes based on a personal or anonymized CV.

1. The Business Orientation Days 2022 handles your personal details very confidentially.
2. The Business Orientation Days 2022 is obliged to present the student's CV to the companies that the student has signed up for.
3. The Business Orientation Days 2022 committee cannot influence the selection of students. Exclusively the participating companies will execute the selection of students.
4. The Business Orientation Days 2022 is in no way responsible when a student is not selected by a company that the student had expressed interest in.

### 2.3. Process to personal program

After the registration deadline for activities with CV selection on Tuesday the 20<sup>th</sup> of September 23:59, the Business Orientation Days committee 2022 will send your CV to the company/companies in question. You will have time to register for activities without CV selection until Monday the 26<sup>th</sup> of September 23:59.

On Wednesday 28<sup>rd</sup> of September, you will receive your preliminary personal program. You will see whether you are selected or on a waiting list for every subscribed activity.

You will have the possibility to deregister for activities without costs until Thursday the 29<sup>th</sup> of September 23:59. See paragraph 2.5 for more information. When you are on a waiting list, you also have to decide to deregister or not, because of the possibility that you are placed anyway when someone else cancels.

On Friday the 30<sup>th</sup> of September you will receive your final personal program. On this day the list with attending students will be sent to our partners. From that moment on our policy regarding late cancellations and no-shows will start. See paragraph 2.6 for more information.

#### **2.4. Communication during the event**

The Business Orientation Days committee 2022 will try to answer as quickly as possible.

#### **2.5. How to unsubscribe**

- Before Thursday 29<sup>th</sup> of September 23:59: deregistering for an activity of the Business Orientation Days can only be done through our website [www.businessorientationdays.nl](http://www.businessorientationdays.nl). If you try to unsubscribe by sending an e-mail, the unsubscribing will be considered invalid.

- After Thursday 29<sup>th</sup> of September 23:59: it is not possible anymore to deregister for activities. After this deadline, cancellations can only be done via e-mail. Late cancellations and/or no-show fees apply, read section 2.6 for more details.

#### **2.6 Late cancellations/no-show policy**

To give everyone a fair chance to participate in popular activities, we have a no-show policy. Our policy contains the following rules:

- **Late cancellations:** you have the possibility to deregister until Thursday 29<sup>th</sup> of September 23:59. If you deregister after this deadline, it will be considered as a late cancellation. For each event day, a fine of €20 will be charged for late cancellation(s).
- **No-shows:** when you cancel on the day of the regarding activity and/or do not cancel at all but yet fail to attend the activity, you will be considered as a no-show. For each event day, one fine of €25,- will be charged for a no-show(s). Next to this, we will communicate your no-show to the regarding company. The regarding company might put you on their **black list** because of the no-show.
- In case of an emergency, we would advise you to contact our secretary Lobke Wilmink as soon as possible [+31 627423760](tel:+31627423760). In case of a sudden illness, it is important that the student can prove their illness with a medical certificate.

The amount of the fine will be automatically deducted and whether it will be deducted cannot be discussed with the Business Orientation Days committee 2022. The Business Orientation Days committee 2022 obligates herself to be cautious when handling out a fine.

## **2.7. Not responsible for theft**

During the Business Orientation Days 2022, the Business Orientation Days committee 2022 is not responsible for any possible damage and/or theft of personal belongings.
